Revenue Services Lesotho Signs a Multi-Institutional Cooperation Agreement to Launch Lesotho Regulators Forum

Maseru, Lesotho – 1 August 2025 - Revenue Services Lesotho (RSL), in collaboration with nine key regulatory and enforcement institutions, officially signed a landmark Multi-Institutional Cooperation Agreement today, marking the formal establishment of the Lesotho Regulators Forum (LRF). The signing ceremony was held at Mojalefa Lephole – Victory Hall, symbolising a significant advancement in Lesotho's regulatory framework.

The newly established Forum brings together the following institutions under a unified regulatory platform:

- Revenue Services Lesotho (RSL)
- Central Bank of Lesotho (CBL)
- Directorate on Corruption and Economic Offences (DCEO)
- Financial Intelligence Unit (FIU)
- Land Administration Authority (LAA)
- Lesotho Communications Authority (LCA)
- Lesotho Electricity and Water Authority (LEWA)
- Lesotho Mounted Police Service (LMPS)
- Lesotho National Development Corporation (LNDC)
- Ministry of Trade, Industry and Business Development (MTIBD)

This cooperative framework aims to foster coordinated regulatory engagement, enhance cross-sector compliance, and improve the overall effectiveness of regulation. By aligning their mandates and operations, the member institutions are committed to cultivating a transparent, secure, and enabling environment for economic and social development.

- Promote collaborative problem-solving and advisory efforts
- Conduct joint investigations and compliance monitoring
- Improve regulatory service delivery across sectors
- Provide coordinated input into national policy-making
- Support inclusive, collective enforcement decision-making

During the ceremony, the LRF Secretariat commended all participating institutions for their commitment, leadership, and shared vision in achieving this milestone.

In her keynote address, RSL Commissioner General and LRF Co-Chair, Mrs. Mathabo Mokoko, stated:

"Today marks a significant step forward in how we, as regulators and custodians of institutional integrity, will engage, collaborate, and drive impact across our respective sectors. This agreement is more than a formality it is a catalyst for sustainable development, institutional coherence, and collective problem-solving in service of the Basotho people."

The agreement is the result of sustained dialogue and collaboration that began in 2020 with the vision of creating a unified regulatory mechanism. The Forum will be governed through structured bodies, including an Executive Committee and a Technical Working Group, to ensure effective oversight and long-term strategic implementation.
