The Government of Lesotho has received financing from African Development Bank hereinafter called the Bank toward the cost of the Lesotho Tax Modernization Project Supplementary Financing and intends to apply part of the proceeds toward payments under the contract for Supply and Deliver HPE Servers and SAN Storage (Pure Storage). For this contract, the Borrower shall process the payments using the Direct Payment disbursement method, as defined in the Bank's Disbursement Guidelines and procedures for Investment Project Financing.
- 2. The Revenue Services Lesotho now invites sealed Bids from eligible Bidders for the Supply and Delivery of HPE Servers and SAN Storage by the 21st November 2025. The goods shall be delivered to the **Government Complex, Finance House Headquarters, Maseru, Lesotho**, within fifty (50) days from contract signature.
- 3. Bidding will be conducted through the Open Competitive Bidding National, (OCBN) method as specified in the Bank's Procurement Framework of October 14, 2015, and is open to all eligible bidders as defined in the Procurement Framework.
